SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT November 16, 2020

The Board of Education of the Salem School District #30, State of Arkansas, met in regular session Monday, November 16, 2020, at 6:00 p.m. in the Boardroom on the high school campus. The meeting was called to order by Chairman Smith.
