SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT November 19, 2018

The board of Education of the Salem School District #30, State of Arkansas, met in regular session Monday, November 19, 2018 at 6:00 p.m. in the Board room on the high school campus. The meeting was called to order by Chairman Smith.

ROLL CALL:

Present: Smith, Coffman, Yarnell, Miller and Hall

Absent: None

The chairman declared a quorum present and opened the meeting for business.

The minutes from the October 15, 2018 regular session meeting were reviewed. Yarnell made the motion, with a second by Hall to approve the minutes as written. The Chairman called for discussion.

The Chairman declared the motion carried.

First on the agenda were high school recognitions. High school Principal Cody Curtis had several student recognitions, congratulations to all on their accomplishments.

Next, Superintendent Wayne Guiltner reported on the purchase of the new bus. Mr. Guiltner and the board members went to the bus garage to view bus #40.

With the purchase of a new bus, we have four spare buses. The bus mechanic sees no need to have more than three spares, therefore we would like to consider selling one bus to the highest bidder. Motion was made by Coffman with a second from Miller to open up bids for bus #18. The Chairman called for discussion.

The Chairman declared the motion carried.

Elementary principal, Corey Johnson reported on the Arkansas School Recognition Program. Arkansas Department of Education awarded schools with top growth and performance with nearly \$7 million, and once again Salem elementary has been awarded money: Top 5% in growth \$45,126.90 and Top 5% in performance \$45,126.90.

The Office of Education Policy (OEP) released their awards and Salem elementary has earned six out of six awards possible.

Bids were taken on a hot water heater and installation in the high school kitchen area. One bid was received (attached). Recommendation was made to accept the bid by McNulty Plumbing for \$7890.00, on a motion made by Hall with a second from Miller. The Chairman called for discussion.
