Superintendent Guiltner reported that a local business, Tri-County Medical Supply & Respiratory Services, Inc., made a request to use the school parking lot for a Car/Bike show with food trucks, bounce houses and dunk a cop at the event. They are wanting to try and make an annual event to bring the community together with a portion of the funds going to the Salem VFW. Mr. Guiltner thought there was no reason to not let them but he would have them sign an MOU. The Date will be June 14, 2025.
