## SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT June 18, 2018

The board of Education of the Salem School District #30, State of Arkansas, met in regular session Monday, June 18, 2018 at 6:00 p.m. in the board room on the high school campus. The meeting was called to order by Chairman Smith.

The chairman declared a quorum present and opened the meeting for business.

The minutes from the May 21, 2018, regular session meeting were reviewed. Coffman made the motion, with a second by Yarnell to approve the minutes as written. The Chairman called for discussion.

The minutes from the May 23, 2018, called meeting were reviewed. Yarnell made the motion, with a second by Hall to approve the minutes as written. The Chairman called for discussion.

Salem Elementary earned the OEP Beating the Odds awards in the following: Statewide High Overall Growth-Elementary Level; Statewide High Math Growth-Elementary Level; Statewide High ELA Growth-Elementary Level; High Math Growth-Elementary Level, Northeast Region.

There are 238 districts in Arkansas with 1053 individual schools. Salem Elementary was #1 out of 1053 schools when looking at student growth.
