SALEM SCHOOL BOARD MINUTES SALEM SCHOOL DISTRICT April 19, 2010

The Board of Education of the Salem School District #30, state of Arkansas, met in regular session on Monday, April 19, 2010 at 7:00 p.m. in the boardroom on the high school campus. The meeting was called to order by Chairman Koelling.

The Chairman declared a quorum present and opened the meeting for business.

The minutes from the March 25, 2010 called meeting were reviewed. Abney made the motion second by Yarnell, to approve the minutes as written. The Chairman called for discussion.

The minutes from the March 15, 2010 regular meeting were reviewed. Abney made the motion, second by Yarnell to approve the minutes as written. The Chairman called for discussion.

Superintendent Ken Rich gave an update on the elementary facility construction progress.

Superintendent Rich presented a proposed school calendar (attached) for the 2010/2011 school year and recommended to tentatively approve the calendar. It will be presented to the personnel policy committee for approval and then finalized at the next board meeting. Yarnell made the motion, second by Abney to tentatively approve the calendar as recommended. The Chairman called for discussion.

Madison Duff scored 12th individual in land evaluation, and Evan Palumbo placed 3rd individual in electricity.

Student transfer petitions were considered. Three students from Izard County Consolidated schools were recommended for transfer to the Salem district. Abney made the motion, second by Yarnell to approve the transfer (attached) as recommended. The Chairman called for discussion.

Yarnell made the motion, second by Abney to accept the resignation as recommended. The Chairman called for discussion.
